Current Accomplishments (FY25)

- 1. One Safe City Received and processed 219 complaints through Intake
- 2. One Safe City Assigned 116 complaint investigations
- 3. One Safe City APD agreed with 75% of the ACRB sustained allegations findings, and APD imposed discipline on 76% of the sustained findings.

- 1. One Safe City Memorandum of Understanding between ACRB and APD
- 2. One Safe City Additional Investigative Staff (25-C-1045)
- 3. One Safe City Kick off for annual community survey

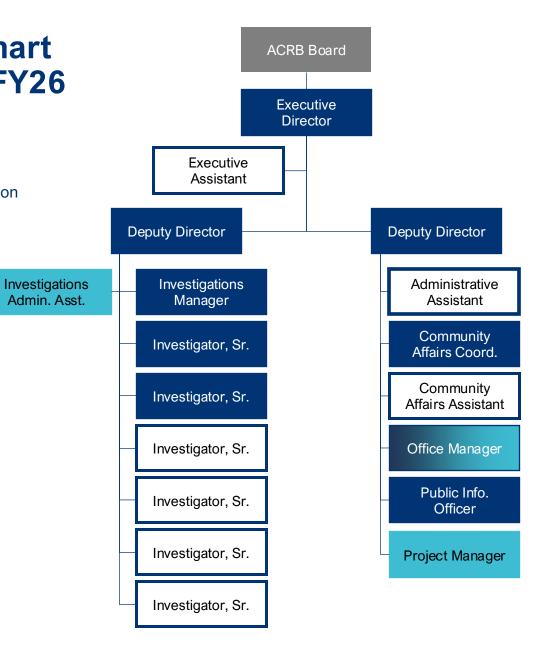
Organizational Chart ACRB Proposed FY26

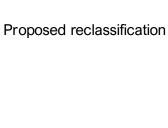

FY25 - FY26 Variance Explanation

Overview of FY25 - FY26 Changes

Proposed increase (\$685.5K) will support full staffing and resource needs. Increase to salaries (\$574K) fully fund all current roles, two new roles, and one role reclassification. Increase in Purchased / Contracted Services (\$111.5K) will fund expanded office space to meet return to office requirements as well as software needs through Axon.

Results of Analysis

Alignment	Program activities are aligned with an Atlanta Citizen Review Board that reaches out to the community to encourage dialogue and, holds the police force accountable through investigations and board oversight. There were 16 positions authorized for this program in FY25. We are requesting 2 more FTEs for FY26.

Budget Impact	This proposal would increase the budget by 41% to \$2,349,281.						
Program Operations	 Community Outreach. <u>Request:</u> Provide \$181,000 over FY25 levels to fully fund outreach staff including a community affairs assistant, administrative assistant, project manager and business manager Investigations. <u>Request:</u> Provide \$338,000 over FY25 levels to fully fund a staff of 6 investigators, an investigator manager, and an investigations administrative assistant at the increased market salary Oversight (ACRB Board). <u>Request:</u> Provide \$55,000 to hire for the vacant Executive Assistant role to support executive leadership and board accountability 						
Return on Investment	The proposed budget will equip the ACRB with a staffing level that is commensurate with other citizen review boards around the nation (per our benchmarking research) and prepare the ACRB for the upcoming increase in OIS investigations.
